

# **Background - Reason for Mismatch or missed Elements**



FACTORS	Courses	Clerkships	Examination
Student	<ul> <li>Absences from courses for personal reasons (do not want to)</li> <li>higher forces (illness,)</li> <li>obligations (eq. Exam at Sending University or other reasons)</li> </ul>	<ul> <li>Subsequent changes by the Student or requests</li> </ul>	Failure in Exam
Receiving institution	<ul><li>Cancellation of courses</li><li>Changes in course offers</li></ul>	<ul> <li>Clerkships not available (no free places, or corona)</li> </ul>	Demands of examination at home
Sending institution	<ul> <li>Changes in curricula (for example due to merges of Universities)</li> </ul>



#### **Transparency - Case of conflict**



Complaints offices for Students:

at the Sending University at National Agency

Legal options in Austria:

Students are legally entitled to lodge a complaint if their Sending university fails to appropriately handle their recognition process, and comprises three key components

Any appeal should be reviewed by an Erasmus Ombudsperson;

Erasmus Ombudsperson will have instant access to all versions of the LA, through a connection to an OLA repositor

#### **Vision – Virtuell options**




- New Erasmusprogramme **blended Learning (virtual mobility) -** Vision
- New bilateral Agreement, Option of Blended mobility included
- Würzburg (virtual courses from home) and additional clinical part at the host institution (clerkships or additional practical part of the course)
- Virtual course offer at the home university as well after Covid-19
- Erasmus+ KA2 project on digital skills: Building an OSCE Digital Library Platform (Capacity building project in higher education)

1. In how far do you consider the problem of recognition relevant for your university? 20 odgovorov




- we don't face difficulties in this matter

2. Which factors would you identify as those that effect the problem of recognition? (Multiple answers possible)




3. Which part of recognition do you consider as most problematic? 20 odgovorov

#### **Results – Best Practice – From Survey**



- Create a mobility window in the medical curricula
- Prepared online recognition tables for each partner
- Allow students to combine courses as well from the following year
- Existing and good online tool to prepare the LA it limits the diffiiculties of recognition at the end
- Retaking exams at the home university if students don't pass exams at the receiving institution
- Offering job-shadowing in case of missing clinical practtice abroad
- Set in advance the minimum number of ECTS needed for exchange

#### – ADVISES:

- Check cours offering when applying for the Erasmus+ exchange
- Appropriate communication and on time communication
