# A. General part (applies to compulsory and elective courses)

# 1. Course objectives

The student will upgrade his knowledge and understanding of pre-clinical and clinical subjects, mostly of the subject "Dental Diseases 1". He will get knowledge about developmental dental defects and dental defects of the functional period among adults. He will gain additional clinical knowledge and skills for independent clinical work on a patient while treating conservative and endodontic cases.

# 2. Comprehensive outline of the course organisation

Compulsatory course. It lasts two semesters, from 9<sup>th</sup> to 10<sup>th</sup> semester of the uniform second-level Master's degree study of Dental Medicine.

- Lectures: 9<sup>th</sup> semester, 1 hour lecture/week (Thursday: 10.00 11.00) Students are advised to attend at least 70% of the lectures.
- Clinical practical lessons: 9<sup>th</sup> semester: 5 hours/week, 10<sup>th</sup> semester: 4 hours/week
  In the form of clinical sessions treating patients and of case presentations and discussions (taking up to 15 minutes). Attendance is mandatory.
  Schedule of lectures and practical lessons is agreed with the enrolled students and published

# 3. Description of on-going assessment of knowledge and skills

Students are assessed on a continuing basis in the conduct of their clinical activities, patient management, treatment planning, and case report presentation. Clinical assessment will include basic clinical skills, data gathering (history and patient examination, accessing the dental literature), clinical reasoning (diagnosis, diagnostic tests interpretation, treatment planning), communication skills. Deficient areas are discussed with assistants.

#### 4. Required conditions for the final examination (Course Exam)

Successfully completed clinical practical lessons and patient assessment forms are the condition for entering the final written part of the course exam.

#### 5. Final assessment and examination of knowledge and skills (Course Exam)

- Written part of the exam (endodontics, dental pathology, cariology: contribute 40% to the grade; operative dentistry: contributes 25% to the grade). It is performed as a combination of up to 30 essay type and multiple-choice questions. It takes up to 60 minutes. There are no deductions for incorrect answers.
- Grade from on-going assessment of knowledge and skills in the *practical part of the course* (contributes 35% to the grade).

# 8. Exam topics, clinical presentations and skills

Upgrading his knowledge and understanding of pre-clinical and clinical subjects, treating conservative and endodontic cases on a patient. Disorders of development of teeth - disturbances in number of teeth, disorders of eruption of teeth, disturbances in form of teeth, disturbances in size of teeth, disturbances of hard dental tissues. Traumatic dental injuries, attrition, abrasion, erosion, tooth resorption, discoloration of teeth, alterations in dentin formation, hypercementosis.

- 2. The Course Regime for *compulsory courses* must be published no later than 14 days prior to the start of the academic year.
- 3. The Course Regime for *elective courses* is also considered the Elective Course Announcement and must be published no later than the 30th of July prior to the start of the academic year in which it enters in force.
- 4. The Course Regime must be published in Slovenian and English.
- 5. In the Course Regime, the »Regulations for the Assessment of Knowledge and Skills for the Single-Cycle Master Study Programmes Medicine and Dental Medicine« will be referred to as "Regulations".
